In 2018, The Stewardship Network hosted 170 on-the-ground trainings and workshops for its diverse and continually growing member base. Over 2,000 people were able to use this information and new skills in caring for their natural areas.

4b (Code:) (Expenses \$ 115,505 including grants of \$) (Revenue \$ 77,385) Training and Events The 2018 Stewardship Network Conference educated, connected, and invigorated over 400 natural areas stewards from across North America. Presenters and participants came from a wide array of backgrounds, including private landowners, tribal members, government agency representatives, professional land managers, researchers, students, and more. This unique interdisciplinary conference continued its superb track record as one of the premier natural areas restoration conferences in the region, while involving an even greater diversity of presenters and participants than in previous years. The 2018 Spring Invasive Species Challenge had extensive engagement and ability to inspire participants from across the United States and Canada to care for natural areas in a collaborative conservation campaign.
