Over 700 people were able to apply these important lessons in their local areas.

It drew presenters and participants from a wide array of backgrounds, including private land owners, tribal members, government agency representatives, professional land managers, academics and researchers, and more. This unique conference continued its superb track record as one of the premier natural areas restoration conferences in the region while involving an even greater diversity of presenters and participants than in previous years. These free, interactive sessions are facilitated by the Network along with experienced practitioners and researchers who are leaders in their field.
